

TERMS AND CONDITIONS OF THE GAME
BARÇA ROOKIES QUIZ
(2017/2018 Season)

1.- SCOPE

FUTBOL FCB BARCELONA (hereafter "FCB"), as part of its "Barça Rookies" initiative for the current 2017/2018 season, aims to encourage boys and girls (underage minors) to attend basketball games played by FCB's first team at the Palau Blaugrana, to which end it has launched a game in which adults and minors can participate.

If participants are minors, their legal representative or the person that has legal custody over them must supervise their participation in each phase of this competition, releasing FCB from any liability in this regard. The descriptions of these phases appear within these terms and conditions (acceptance of terms and conditions, participation requirements, contest dynamics, prize acceptance, cession of image and intellectual property rights, etc.).

2.- PARTICIPATION REQUIREMENTS

2.1. Anyone who wants to participate in the activity must meet the requirements which are detailed below:

- Be registered members at <https://www.fcbrookies.cat/es/index.php>.
- Play the Barça Rookies Quiz through the website: <https://www.fcbrookies.cat>, supplying the required information.
- Participate in at least one (1) of the weekly quizzes about FCB Barça Lassa and the world of basketball in general.
- Each participant will be eligible for one (1) quiz entry per week, and the registration shall only be carried out once.
- FCB shall identify any duplicate entries, which means it shall only accept one (1) weekly entry per participant. It shall deem any additional entries the same participant may have made as null and void.
- Participation in one (1) weekly game gives the entrant the right to participate in the Barça Rookies Quiz ranking, the Top 10 of which will win the grand prize.

2.2. All the individuals who meet the previously indicated requirements can participate in the contest. If participants are minors, their legal representative or the person that has legal custody over them must supervise their participation.

3.- PRIZE

Two prize categories will be awarded:

1.- One (1) Barça Rookies hat for each of the ten (10) winners of the weekly draw among all the participants in the Barça Rookies Quiz. The game shall last for ten (10) weeks and, therefore, there will be ten (10) draws. All the hats will be sent once the game is finalised at the end of September 2017.

2.- One (1) ball signed by the Barça Lassa team and two (2) tickets to the first game of the basketball season that FCB Lassa will play at the Palau Blaugrana for each of the ten (10) top ranking winners of the Barça Rookies Quiz. The ball will be given to the winners on the same day as the prize game.

If the winners are minors, they must attend the prize game accompanied by one (1) adult. This person may be a parent and/or a person of legal age who is authorised to be their legal representative or legal guardian.

4.- CONTEST DYNAMICS

4.1. Each week during the ten (10) weeks that the game will last, through a random lottery program installed on the Barça Rookies website, one (1) weekly winner and two (2) runners-up will be chosen from among all the participants, who will receive the prize indicated in section 3.1.

4.2. At the end of the contest, the ten (10) participants with the highest score in the quiz ranking will win the prize indicated in section 3.2. In the event of a tie, a draw will be made among all the winning users who have obtained the same score.

4.4. Once the winners are designated, their names will be communicated to the Notary Public so that a notarial certificate can be issued identifying the people who have been selected.

4.6. In the event that the winners refuse the prize for any reason or circumstance, the condition of winner shall pass on to the person who has the condition of runner-up, and the next individual in the Barça Rookies Quiz ranking, respectively.

5.- COMPETITION COMMUNICATIONS

The communications related to the competition and/or events described in the current terms and conditions, and the participation rules, shall be laid out on the website www.fcbarcelona.cat and/or <https://www.fcbrookies.cat/es/index.php>. The winners shall receive all communication by telephone or e-mail, through the telephone number and/or e-mail address indicated on the participation/registration form. The verbal communication by phone call, which will be recorded, to the phone number indicated, and/or written communication to the e-mail address provided, shall serve as means of proof, for all intents and purposes, of the communication carried out by FCB, informing about said condition and the prize collection.

6.- PRIZE ACCEPTANCE

Once the winners find out they have won a prize, as previously expressed, they must respond in writing by indicating their (i) acceptance or (ii) refusal of the prize in question (this communication must therefore come before the prize has been delivered or, where applicable, received) so that:

- a) In the event that the winner accepts the prize, FCB can proceed to deliver the prize under the indicated conditions. These winners, or when the prize corresponds to a minor, the minor's legal representative, must sign a document that shall contain their acceptance in writing of the corresponding prize and receipt of it under the condition that they cannot make any claim or request anything else from FCB.
- b) In the event that the winners do not accept the prize, the winners must also express this refusal in writing. On this note, FCB expresses that the aforementioned prize may not under any circumstances be exchanged for another prize or for its cash value. The condition of winner therefore shall pass over automatically to the first runner-up and to the next-highest individual in the Barça Rookies Quiz ranking, respectively. FCB shall proceed to award the prize to this participant, following the same procedure, and so on and so forth.

For the aforementioned purposes, in the case of underage minors, the prize must, under all circumstances and without qualification, be accepted or refused by the adults that hold their legal guardianship, on their behalf and representing them. FCB shall be exempt from any liability in this regard.

The prize must solely be enjoyed by the winner. As a consequence, the sale of any element that makes up the prize and/or any type of paid cession or transfer associated with the prize is strictly prohibited and may lead to automatic revocation of the prize and cancellation of its content **without any type of compensation.**

In the event that the winner does not comply with FCB's logistical instructions on how to collect the prize, or fails to do so within the established period and times, and does not claim force majeure and/or any other justified impediments, FCB shall interpret this as the winner refusing the prize. The prize will therefore revert to FCB so that it can use it in any way it deems appropriate.

7.- IMAGE RIGHTS

According to these terms and conditions, the winners and, in the case of minors, the person who holds their legal representation and guardianship, give their express consent to FCB, at their own will and for all purposes, to record their image (including their likeness, name and voice) through photographs and/or audiovisual recordings, whether individually or collectively, whether by FCB staff members or authorised third parties, related to moments when the winners collect the prize and/or while they enjoy the prize, as well as their participation in possible interviews and/or reports, and give their consent for FCB to use this material for advertising purposes.

In this regard, FCB shall be authorised to make use of the aforementioned graphic materials, as well as copies of them, either fully or partially, for promotional events and/or information related to this contest, or other purposes, at any FCB press events. FCB may handle them directly, or authorise and assign third parties to do so, in compliance with its statutory goals, with winners renouncing any compensation and/or claim under any circumstances in connection with these photographic images or videos and the cession of their image rights. As per the above, any promotional and advertising materials or media, current and/or future, which may feature an individual or group picture of the winners, is and shall be the property of FCB.

8.- ERRONEOUS DATA AND PERSONAL DATA

If an error exists in the data that appears on the participation/registration form that makes it impossible to identify the participants and/or contact them by telephone or in writing, FCB shall be exempt from any responsibility.

Additionally, in accordance with the provisions of Organic Law 15/1999, of 13 December, on Personal Data Protection (LOPD), plus any complementary regulation and/or development thereof, data from participants shall only be processed so that FCB can make any communications it deems appropriate either directly or through authorised third parties for the following purposes related to:

- This competition, including managing the delivery of the relevant prize,
- The "Barça Rookies" initiative and the FCB basketball division,
- Anything else related to the sporting and/or social events and/or anything else FCB could organise and develop, in compliance with its statutory goals,
- As well as for informative, commercial and promotional purposes in regard to matters, processes, new features, products or services owned by FCB or any of its sponsors and/or partners that could interest the participant.
- The publication of the first and last names of the winners on the official FCB website: www.fcbarcelona.cat, and/or the website of "Barça Rookies": <https://www.fcbrookies.cat/es/index.php>.

In the event that the winners of the draw and the winners of the Barça Rookies Quiz ranking do not wish this data to appear on the cited websites, they must expressly communicate this to FCB.

Finally, in accordance with the stipulations of Law 34/2002, of 11 July, on Information Society and E-Commerce Services, modified by Royal Decree Law 13/2012, the winning participants expressly authorise FCB to send communications and messages that contain information, promotions and commercial offers related to the services and products that FCB wants to sell to the e-mail address and mobile telephone number that appear on the participation form for this competition.

The winners can, at any time, exercise their right to access, rectify, oppose and/or cancel the use of their data and/or its processing by sending a written communication, together with a photocopy of their Spanish National Identification Card (DNI), to the registered address of the entity responsible for the file: Futbol Club Barcelona, C/ Aristides Maillol, s/n, 08028 Barcelona or the following e-mail address: lopd@fcbarcelona.cat, specifically expressing the right they wish to exercise and the reasons.

9.- PRESENTATION OF THESE TERMS AND CONDITIONS BEFORE A NOTARY

These terms and conditions shall be presented to a notary belonging to the Il·lustre Col·legi de Notaris de Catalunya.

10.- PUBLICATION OF THESE TERMS AND CONDITIONS

These terms and conditions shall be published on the FCB website: www.fcbarcelona.cat, and on the "Barça Rookies" website: <https://www.fcbrookies.cat/es/index.php>, for the purpose of informing all those persons interested in participating about the dynamics of participation and how the contest functions.

11.- ACCEPTANCE OF THESE TERMS AND CONDITIONS

Participation in this activity implies the complete acceptance of the terms and conditions as well as an awareness of the dynamics of participation.

In the event that differences of opinions exist about the promotion and/or interpretations of these terms and conditions, the Courts and Tribunals of Barcelona shall be competent for any legal action. Participants therefore expressly waive any other jurisdiction to which they may otherwise be entitled.

12.- MISCELLANEOUS

a) Access to the Palau Blaugrana shall be subject to fulfilment of:

- Specific rules of this facility owned by FCB.
- Stipulations of any applicable legislation in the field of entry, security, health, etc.

b) Additionally, access to the Palau Blaugrana may involve the following activities for security purposes:

- Inspections.
- Searches.
- Etc.

c) The documentation that proves the condition of being the winner is personal and non-transferable, under any condition and/or circumstance. The winner must therefore use the prize and be responsible for its proper use. As a consequence, its sale and/or any other type of paid cession or transfer are strictly prohibited, as is its use for marketing, advertising or promotional purposes (including contests, gifts and/or draws). Failing to comply could lead to an automatic revocation of this prize without any type of compensation, and immediate notification to the FCB Disciplinary Committee of these activities so that it can adopt the appropriate measures (in the event that the winner is an active member of FCB).

d) FCB informs participants in the competition that it reserves the right to request official documentation that contains a picture and a signature of its holder for identification purposes so as to control entry to the Palau Blaugrana (DNI, NIE, Passport, etc). In the event that any irregularity is detected, such as if documentation used to verify the identity of the winner does not match the indicated information, FCB shall deny this person entry to the Palau Blaugrana. FCB reserves its right to make this decision. This shall automatically cancel this person's status as the winner, **without entitlement to any type of compensation**. FCB may proceed to notify its Disciplinary Committee of this behaviour (in the event that the winners are active members of FCB) so it can adopt the appropriate measures, as well as the corresponding authorities (where applicable) so that they can adopt the corresponding administrative, official and/or legal measures.

e) The winners must keep the documentation that proves their condition as the winners with them throughout the entire duration of the match as well as while they remain inside the Palau Blaugrana facilities. The winners, if necessary, may need to show this documentation to authorised FCB personnel.

f) FCB is not responsible for any loss or theft of the documentation that proves their condition as the winner.
